Introduction

SAP Business One allows you to create Quotations, Sales Orders, Deliveries, and A/R Invoices. But along the way, orders have to be shipped. Many companies use separate computer systems or web services for UPS, FedEx, US Postal Service, and LTL carriers. Maintaining multiple databases for customer addresses, and entering information for each shipment is time-consuming and a likely source of errors.

The ***Achieve Freight Control*** module serves as a bridge between SAP Business One and the carrier shipping systems. All relevant information for each order is copied to a Shipping Request document. Operators may enter the quantity shipped and packaging information, and verify shipping charges. The data is transmitted to the carrier's system, and final charges and tracking numbers are returned. Finally, the Delivery document and/or Invoice may be automatically created from the Shipping Request.

In addition, ***Achieve Freight Control*** includes a Rate Shopping feature, which allows operators to view shipping rates by various carriers and shipping options, from within the Sales Order screen. This enables them to provide accurate estimates of shipping charges to customers at the time the order is placed.

Major features of **Achieve Freight Control** include:

Shipping Request

Create from Sales Order, Reserve Invoice, or Pick Ticket

May include items from multiple orders

Includes:

- Quantities Shipped
- Shipping Method
- Billing, Ship-To and Ship-From Addresses
- Billing Information
- Packaging
- Additional Charges

Automatically Create Deliveries and/or Invoices

Shipping Management

- Process groups of Shipping Requests together
- Change the status of Shipping Requests
- Create Delivery and/or Invoice documents

Rate Shopping

- Display on Sales Order Screen
- View Rates for multiple carriers and shipping methods
- Quote rates to customer
- Select desired carrier/method

Setup

There are a number of setups that must be entered before **Achieve Freight Control** can be used. These are located primarily under the *Administration > Achieve One > Achieve Freight Control menu*. They are described in detail in the following section.

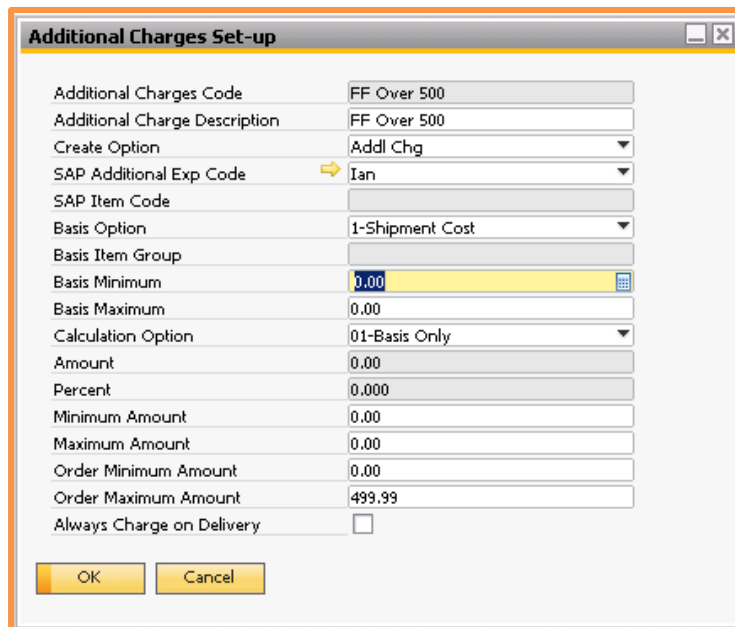
Please note that it is also necessary to make various mappings and other setup entries in the carrier software systems, such as UPS WorldShip®. See the **Achieve One Freight Control Installation Guide** for instructions on these procedures. Also consult with the carrier representatives for assistance with these entries.

Additional Charges Set-up

Administration > Achieve One > Achieve Freight Control > Additional Charges Set-up

This program is used to enter various charges that may be calculated before applying freight charges to a customer's invoice. You may select from several different methods of calculating these charges. Up to ten additional charges may be entered as system defaults, on shipping methods, and ultimately on individual shipments.

Note that the sum of all Additional Charges on a shipment will replace the actual amount charged by the carrier when applied to the customer's invoice. If there are no Additional Charges on a Shipping Request, then the actual amount charged will be applied.

Additional Charges Code Enter the code for this type of charge (20 characters).

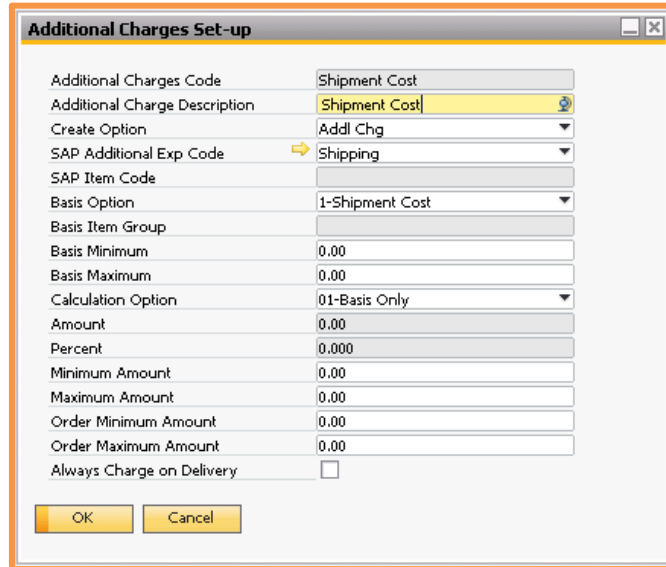
Additional Charges Description Enter a description for the charge (50 characters).

Create Option	Select the method of adding the charge: <ul style="list-style-type: none">• Addl Chg – enter as a freight-type charge in the footer of the Business One document• Item – enter as a separate row in the body of the Business One document
SAP Additional Exp Code	If the Addl Chg option is selected above, select the Business One freight code to use for this charge.
SAP Item Code	If the Item option is selected above, enter the item code to use for the charge.
Basis Option	Select the basis for the calculation of this charge. This is the value that will be used in the calculation option selected below: <ul style="list-style-type: none">• Shipment Cost• Shipment Value• Order Value• Number of Packages• Weight• Volume• Quantity• Sales Order• Rate Quote (This option is only available on older installations. If you quote a rate shop it will automatically set the additional charges on the Shipping Request as Rate Quote. There is no need to create an actual Additional Charge for Rate Quote)• Flat Fee on Basis Item Group
Basis Item Group	If the basis is Flat Free on Basis Item Group, this is the item group that it will trigger a charge.
Basis Minimum	Enter the minimum basis amount if needed. If the basis amount is less than this amount then the charge will not be incurred.
Basis Maximum	Enter the maximum basis amount if needed. If the basis amount is greater than this amount then the charge will not be incurred.

Calculation Option	Select the option for how to calculate the charge (Note: The * indicates multiplication): <ul style="list-style-type: none">• Basis Only• Stated Amount• Basis * Percentage• Basis * Amount• (Basis * Percentage) + Amount• Basis + Percentage• Basis + Amount• (Basis + Percentage) + Amount
Amount	If the calculation option requires an amount, enter the amount.
Percent	If the calculation option requires a percentage, enter the percentage.
Minimum Amount	If there is a minimum amount to be charged when calculating the additional charge amount, enter the minimum amount.
Maximum Amount	If there is a maximum amount to be charged when calculating the additional charge amount, enter the maximum amount.
Order Minimum Amount	Enter the minimum order amount if needed. If the order amount is less than this amount then the charge will not be incurred.
Order Maximum Amount	Enter the maximum order amount if needed. If the order amount is greater than this amount then the charge will not be incurred.
Always Charge on Delivery	If this box is checked then this additional charge will be used even when the Shipping Method or Shipping Spec is set to something other than “Bill Company” (this will be further explained later on in this document).

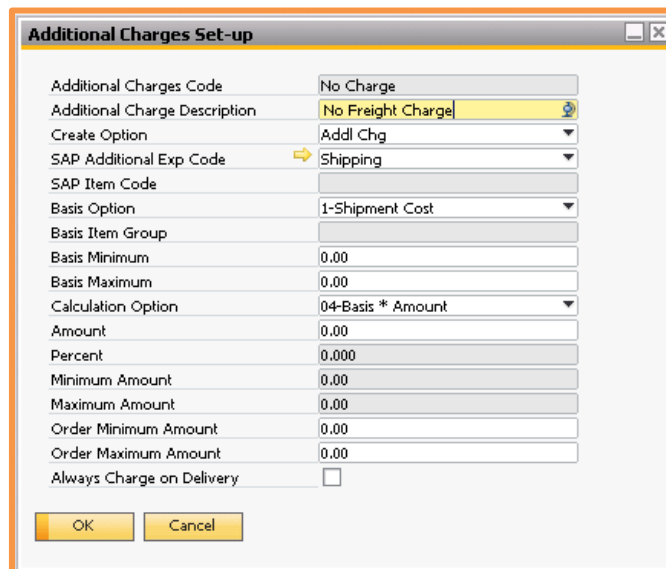

Shipment Cost is the basis and the calculation is the basis only, so the charge will be the shipment cost.

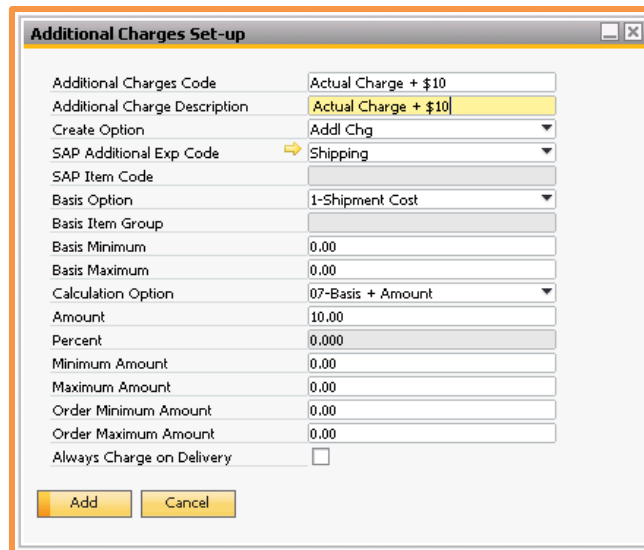

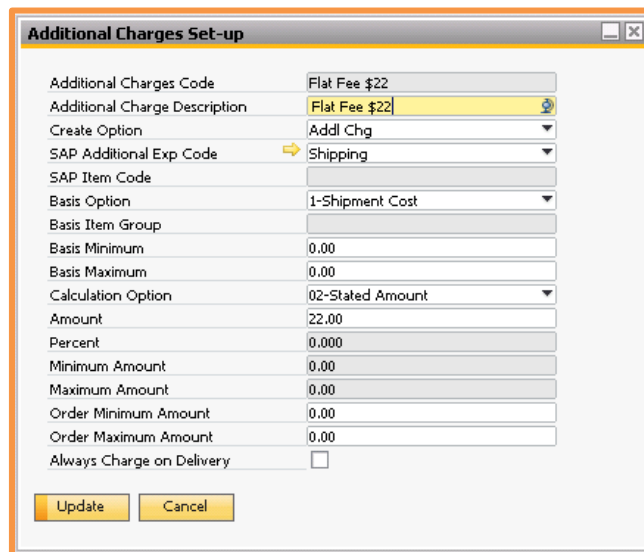

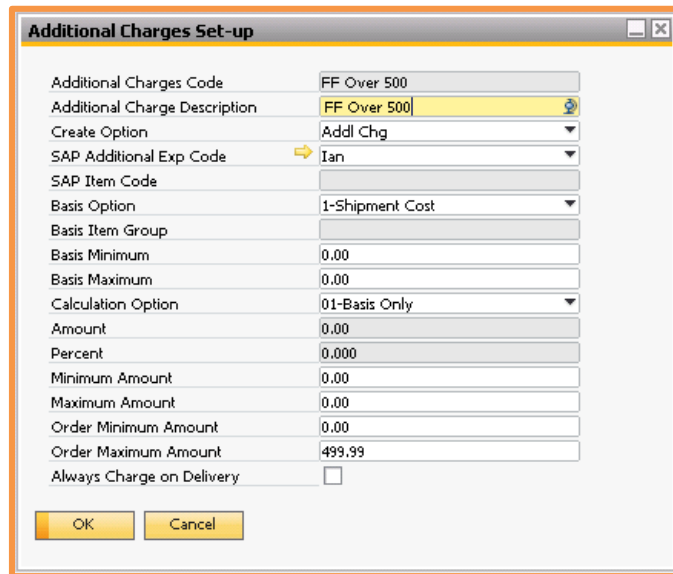

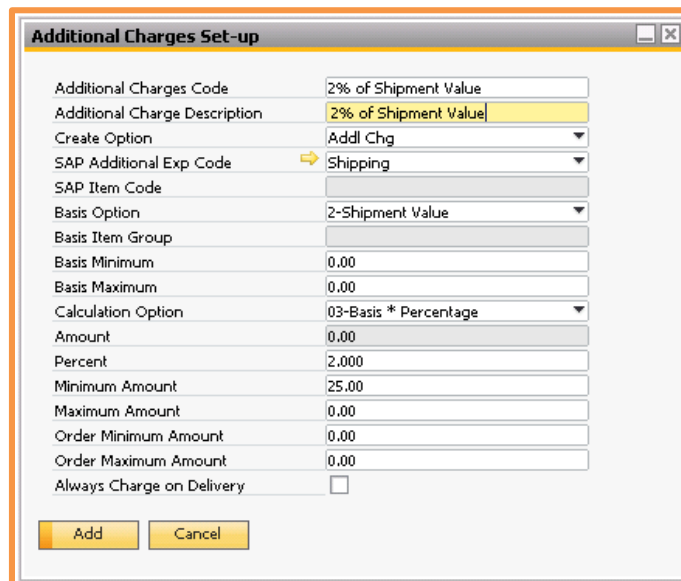

Enter the following information in the upper section of the screen:

<i>Carrier Code</i>	Enter a code for the carrier (10 characters).
<i>Carrier Name</i>	Enter the carrier's name (50 characters).
<i>Account Number</i>	Enter your company's account number for this carrier (50 characters).
<i>Internal Carrier Code</i>	Select the internal code for this carrier. These codes are preset in the system. Only carriers in this list may be selected. Choose from the following: <ul style="list-style-type: none">• None (no rate shopping is possible)• UPS• FEDEX• DHL• USPS• ABF
<i>Tracking URL</i>	Enter the complete URL to be used when tracking a shipment from this carrier (254 characters)
<i>Rate Shop URL</i>	Enter the complete URL to be used when checking rates from this carrier if rate shopping is to be used (254 characters)
<i>Rate Shop License</i>	Enter your rate shopping license from this carrier (50 characters)
<i>Rate Shop User ID</i>	Enter the user ID for rate shopping from this carrier (50 characters)
<i>Rate Shop Password</i>	Enter the password for rate shopping from this carrier (50 characters)
<i>Rate Shop Max Weight</i>	Enter the maximum weight per package that is allowed for rate shopping from this carrier
<i>Auto Print Delivery</i>	If Freight Control is set to Enable Carrier Setup Auto Print Delivery (found in the Freight Control Configuration) check this box to have delivery documents automatically print for this carrier

In the lower section of the screen, enter a list of the service level codes used by this carrier. Service levels represent different types of delivery service and rates that are offered. For example, a carrier may offer Ground, Next Day Air, Second-Day Air, and so on. The service level code should correspond to the carrier's own code for the type of service. Although it is in your best interest to make them match, the codes do not need to be identical. However there should be a direct relationship between service levels and the carrier's delivery service options. You do not need to enter all possible codes, just the ones that your company will be using.

Note: Again, although you may use any codes you wish for the various service levels, integration with the carrier's shipping system (for example, UPS WorldShip®) will be easier if you use the same codes as the carrier.

Do not include payment options such as COD or Third-party billing, as these do not represent types of delivery service.

If you are going to use Rate Shop make sure you select the corresponding Rate Shop Codes from the drop down.

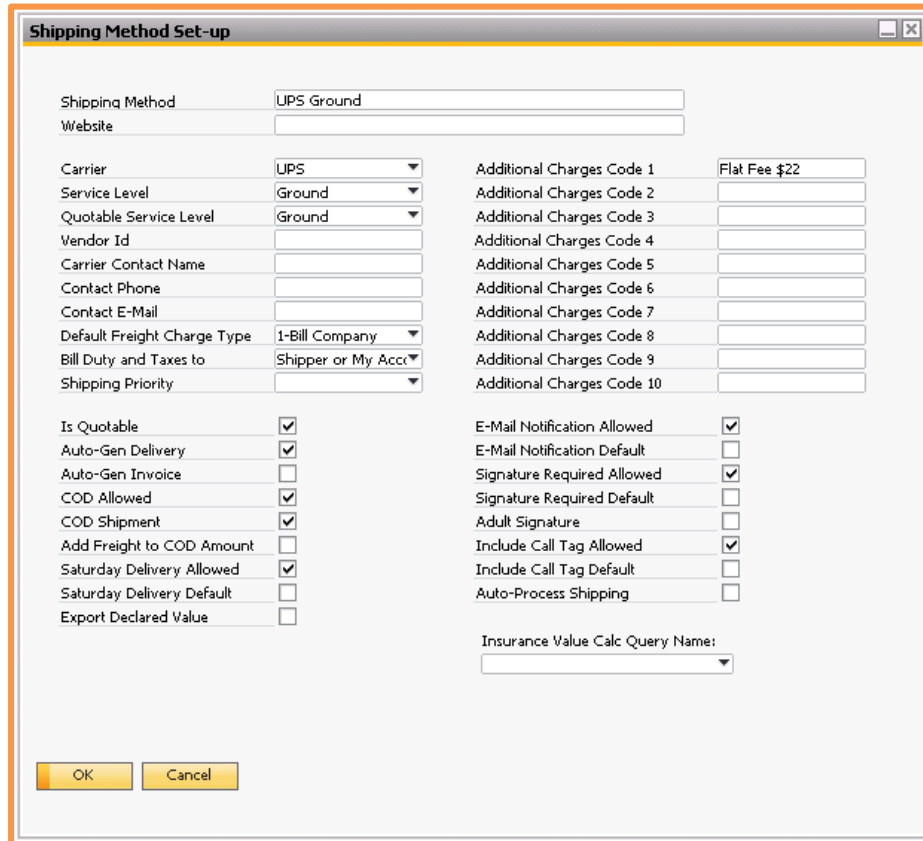
You should also add a Service Level Description so that the service level codes are easier to recognize when populating drop down lists.

Shipping Method Set-up

Administration > Achieve One > Achieve Freight Control > Shipping Method Set-up

This program allows you to enter various parameters and conditions for the Shipping Methods that are used with **Achieve Freight Control**.

Note: The Shipping Methods should have been previously entered in the standard Business One Shipping Types setup, found in Administration > Setup > Inventory > Shipping Types.



If the code already exists use the Find option to pull it up. If it does not then enter a code for the new shipping method. The new code will be added to the Business One Shipping Types.

Enter the following information:

Website Enter the shipper’s website address.

Carrier Select a carrier code from the drop-down list.

Service Level Select a service level. The drop-down list displays the service levels that have been established for this carrier.

Quotable Service Level Select a service level that will be used for quoting when using rate shopping. It is not required to be the same as the actual service level used; for example, you can rate shop as if the order is going to ship ground and have the service level be Next Day Air. This would indicate that you would charge Ground rates for Next Day Air delivery.

Vendor ID Enter the Business Partner code for the carrier’s Vendor record if needed.

Carrier Contact Name Enter the name of the person who is your contact at the carrier company.

Contact Phone Enter the contact’s phone number.

Contact Email Enter the contact’s email address.

Default Freight Charge Type Select the default charge type for this shipping method. This indicates who the shipping company will bill for the freight charges. Choose from:

Bill Company Gets billing address from Company Details, and account number from carrier setup.

Bill Customer Gets billing address from sales order customer, and account number from the BP Master.

Bill Ship-To Gets billing address from sales order ship-to, and account number from ship-to address on BP Master.

Bill Consignee Consignee billing address and account number must be entered on Shipping Request.

Bill Third Party Third Party billing address and account number can come from Shipping Specification or must be entered on Shipping Request.

Bill Duty and Taxes To Select the default type of billing for duty and taxes. Choose from:

- SHP – Shipper or My Account (shipper number)
- REC – Receiver
- TP – Third Party
- CB – Consignee Billed

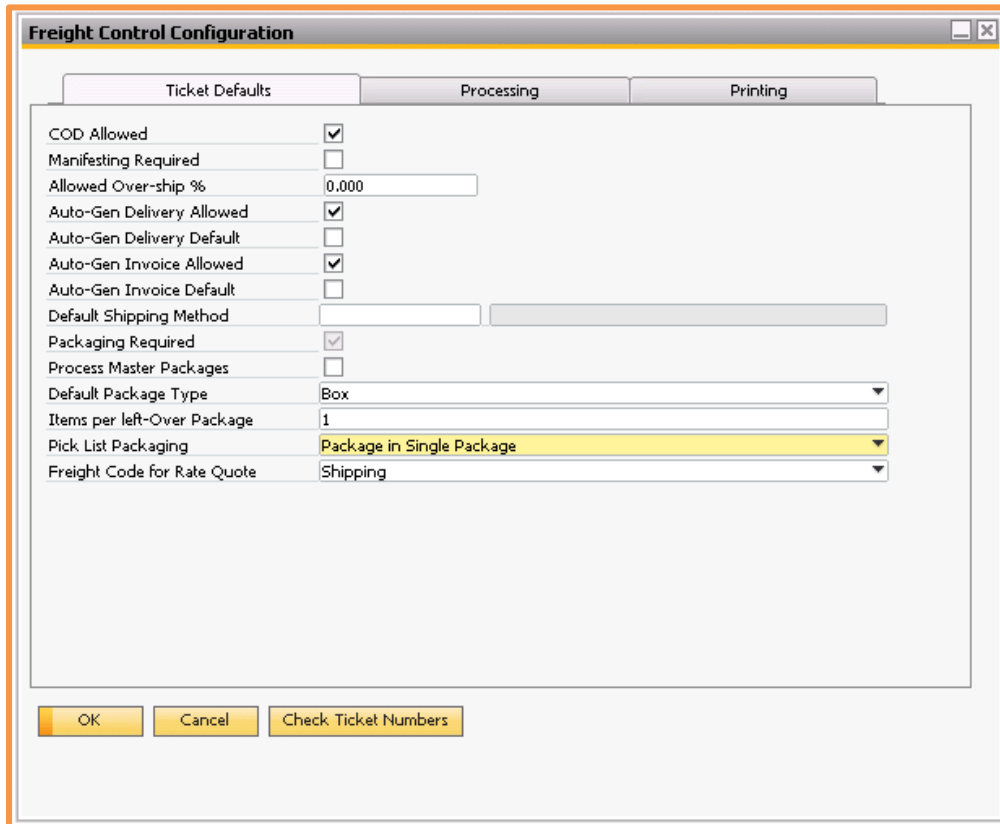
<i>Shipping Priority</i>	If desired, set a priority level for this Shipping Method. The list of priority codes may be entered in the Shipping Types Setup (<i>Administration > Setup > Inventory</i>). The priority code can be used as a selection criterion in the Warehouse Logistics Manager, if using <i>Achieve Warehouse Management</i> .
<i>Is Quotable</i>	Check if this shipping method should appear in the Rate Shopping list for the carrier.
<i>Auto-Gen Delivery</i>	Check if Delivery documents are to be automatically generated during the shipping process.
<i>Auto-Gen Invoice</i>	Check if Invoice documents are to be automatically generated during the shipping process.
<i>COD Allowed</i>	Check if COD deliveries are permitted with this shipping method.
<i>COD Shipment</i>	Check if the shipment should be marked COD. This can only be checked if COD is allowed.
<i>Add Freight to COD Amount</i>	Check if the freight charges should be added to the shipment amount for the COD total amount. This can only be checked if COD is allowed.
<i>Saturday Delivery Allowed</i>	Check if Saturday delivery is permitted with this shipping method.
<i>Saturday Delivery Default</i>	Check if Saturday delivery is the default option for this shipping method. This can only be checked if Saturday delivery is allowed.
<i>Export Declared Value</i>	Check if you want to export the declared value from the shipping request.
<i>Email Notification Allowed</i>	Check if email notification is allowed for this shipping method.
<i>Email Notification Default</i>	Check if email notification is the default option for this shipping method. This can only be checked if email notification is allowed.
<i>Signature Required Allowed</i>	Check if the signature required option is allowed for this shipping method.

<i>Signature Required Default</i>	Check if signature required is the default option for this shipping method. This can only be checked if Signature Required Allowed is checked.
<i>Adult Signature</i>	Check if an adult signature is required. This can only be checked if Signature Required Allowed is checked.
<i>Include Call Tag Allowed</i>	Check if Call Tags are allowed to be generated with this shipping method.
<i>Include Call Tag Default</i>	Check if generating Call Tags is the default option for this shipping method. This can only be checked if Include Call Tags Allowed is checked.
<i>Auto-Process Shipping</i>	Check if you want shipping requests to automatically be changed to Shipment Info Received status automatically after packing. This is usually not used with Carrier integration shipping methods since those will do this automatically during the Carrier software export process.
<i>Additional Charges (1 through 10)</i>	Select one or more additional charges to be computed with this shipping method if needed.
<i>Insurance Value Calc Query Name</i>	Select a query from the dropdown list of User Queries that indicates how the value for insurance should be calculated for an order if needed. This query will run and populate the Insurance Amount field for the shipping request.

This program allows you to enter general defaults for the use of the Freight Control system. It consists of three tabs.

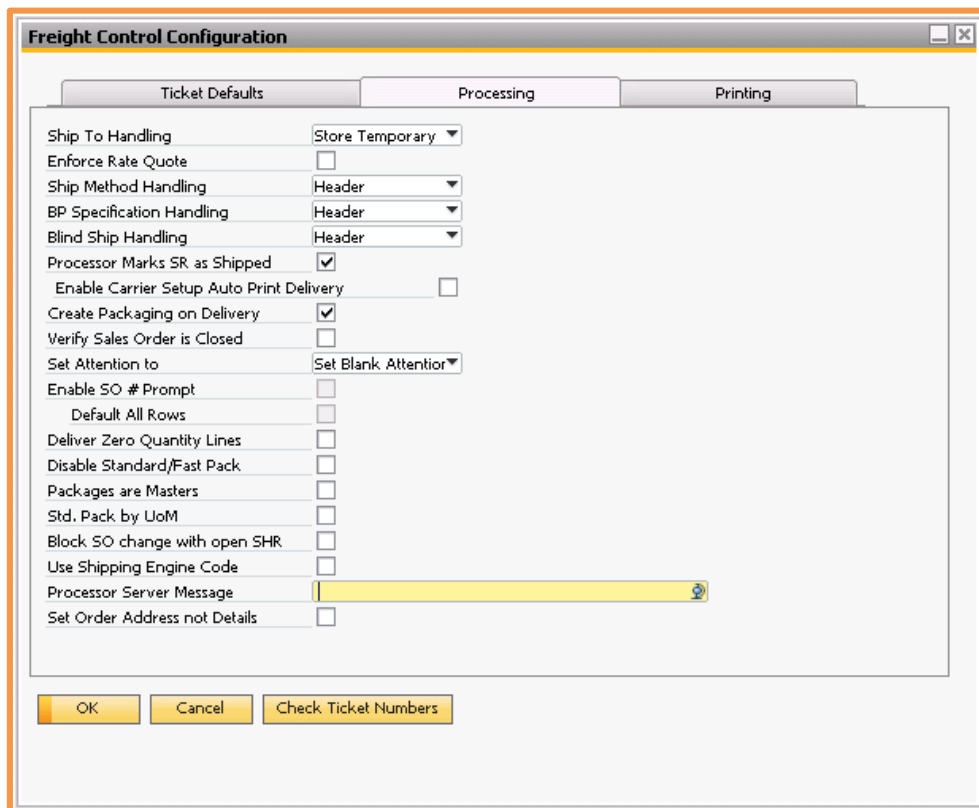
Ticket Defaults Tab

- COD Allowed*** Check if COD shipments may be entered.
- Manifesting Required*** Check if a manifest is required for every shipment. In this case, the system will not create Deliveries or change the status to Completed until the shipping requests are manifested.
- Allowed Over-ship %*** Enter the percentage of over shipment that is allowed, if any.

<i>Auto-Gen Delivery Allowed</i>	Check if the system can automatically generate Delivery documents from the Shipping Request.
<i>Auto-Gen Delivery Default</i>	Check if the system should default the auto-generate delivery checkbox as checked when creating a new shipping method.
<i>Auto-Gen Invoice Allowed</i>	Check if the system can automatically generate Invoice documents.
<i>Auto-Gen Invoice Default</i>	Check if the system should default the auto-generate invoice checkbox as checked when creating a new shipping method.
<i>Default Shipping Method</i>	Select the default Shipping Method from the list of methods entered in Business One.
<i>Packaging Required</i>	Check if package designations are required for every shipment. In this case, detailed packaging is required for all items to identify what contents are in which package. If the box is not checked, the system assumes everything is in one package (Package 0) for shipping purposes.
<i>Process Master Packages</i>	Check if you will be processing master packages, which contain smaller packages.
<i>Default Package Type</i>	Select the default Package Type from the list of SAP package types.
<i>Items per left-over package</i>	Indicates how many loose items can be placed into a box after consuming full standard pack quantities. This is for the purpose of calculating a planned number of boxes when rate shopping.
<i>Pick List Packaging</i>	When using the SAP Pick/Pack Manager select how the items should be packed by default when a Shipping Request is created: <ul style="list-style-type: none">• No Packaging• Package in Single Package• Package using Standard Packaging
<i>Freight Code for Rate Quote</i>	Select the freight code to be used for the rates quoted. Select from the list of Business One freight codes. Note that this code will also be used when applying actual shipping charges to an invoice if no Additional Charges exist on the Shipping Request.

On the bottom of the screen is a button labeled Check Ticket Numbers. Although rare, sometimes the shipping request numbers can become out of sync in the database tables. If this happens, you can use this button to make sure that all the Shipping Request document numbers are matched up correctly in all of the Shipping Request tables.

Enforce Rate Quote

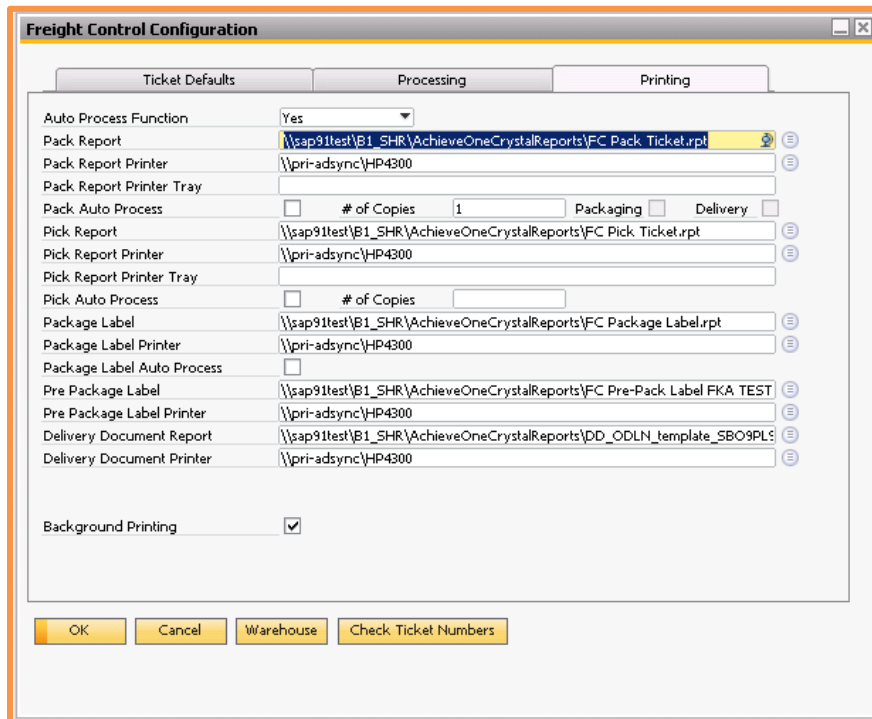
Check if users are required to use the Rate Shopping function for all Sales Orders.

<i>Ship Method Handling</i>	Select the way in which the Freight Control program will process the shipping method: <ul style="list-style-type: none">• Header: use the shipping method in the Sales Order header (Logistics tab)• Line: use the shipping method on each row of the Sales Order (e.g., different items may have different shipping methods). If the lines differ this will result in multiple shipping requests per Sales Order

<i>Deliver Zero Quantity Lines</i>	Check this box if you want zero quantity lines on the Shipping Request to be added to the Delivery document.
<i>Disable Standard/Fast Pack</i>	Disables the Standard Pack and Fast Pack buttons on the Shipping Request screen.
<i>Packages are Masters</i>	If you enable Master Packaging, check this option if you want regular packages to be considered Master Packages as well.
<i>Std. Pack by UoM</i>	Check this box if you want to use the Standard SAP UoM and Package Types screen on the Item Master to determine standard packaging instead of the Achieve One created fields on the Item Master.
<i>Block SO change with open SHR</i>	Blocks any changes to a Sales Order that has an open Shipping Request linked to it.
<i>Use Shipping Engine Code</i>	This is for future functionality.

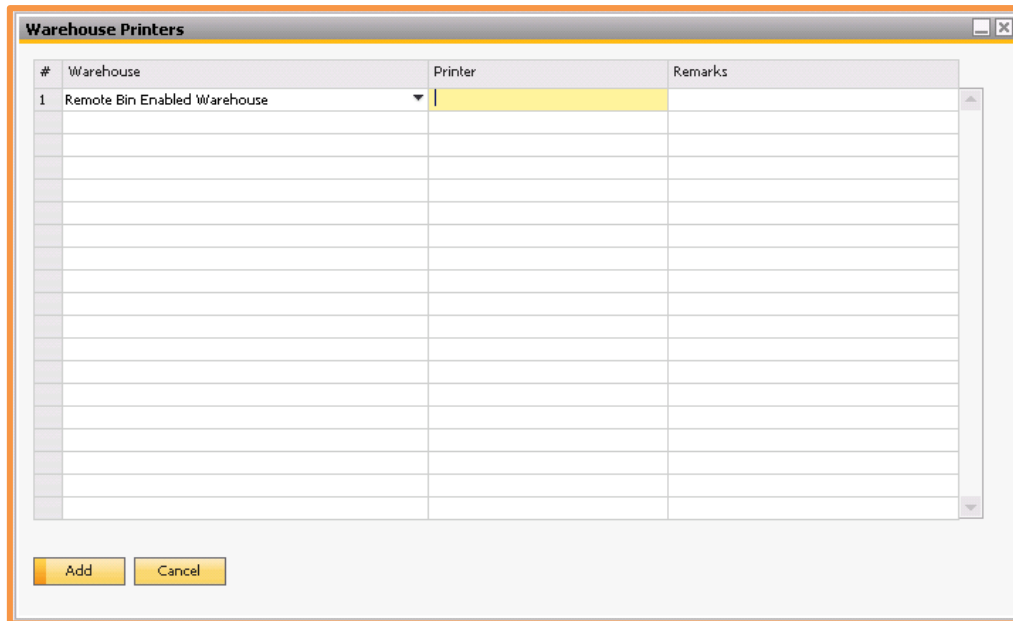

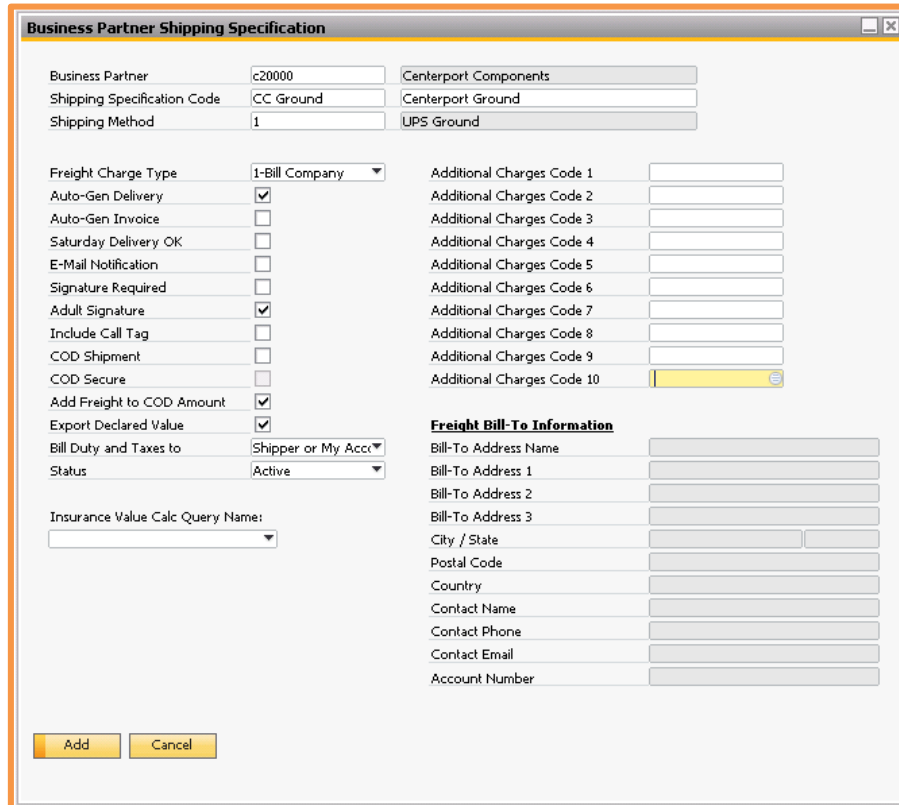
BP Shipping Specifications

Administration > Achieve One > Achieve Freight Control > BP Shipping Specification

This program may be used to enter unique specifications for a particular customer when using a particular shipping method. You may wish to enter these specifications as a result of contract agreements with certain customers, credit issues, or other reasons.

The BP Specification will override the normal settings for the indicated shipping method; it is not necessary except in cases where exceptions from the defaults are desired.

Note: The BP Specifications may be assigned to a Business Partner record, in which case it will apply to all Ship-to addresses for that BP, or it may be applied to specific individual Ship-to addresses. BP Specifications applied to Ship-to addresses will override the BP Specification on the BP Master.



Enter the following information:

Business Partner Enter the BP code for the customer

Note: It is not necessary to enter a BP code in the Shipping Specification. You may wish to attach the same specification to multiple customers.

Shipping Specification Code and Description Enter a code and description for this specification (30 characters for the code, 100 characters for the description).

- Bill Ship-To

<i>Auto-Gen Invoice</i>	Check if Invoice documents are to be automatically generated during the Shipping process.
<i>Saturday Delivery OK</i>	Check if the Saturday delivery is permitted for this specification.
<i>Email Notification</i>	Check if the email notification is to be provided for this specification.
<i>Signature Required</i>	Check if a signature is required for this specification.
<i>Adult Signature</i>	Check if an adult signature is required for this specification.
<i>Include Call Tag</i>	Check if call tags are to be generated for this specification.
<i>COD Shipment</i>	Check if shipments under this specification are to be sent COD.
<i>COD Secure</i>	If the COD Shipment is selected, check if the COD shipment is secure.
<i>Add Freight to COD Amount</i>	Check if you wish to add the freight charge to the COD amount, so the recipient will pay both together on delivery.
<i>Export Declared Value</i>	Check if you want to export the declared value from the shipping request.
<i>Bill Duty and Taxes To</i>	Select the method for billing Duty and taxes on international shipments: <ul style="list-style-type: none">• Shipper or My Account (shipper number)• Receiver• Third Party• Consignee Billed
<i>Status</i>	Select the current status of this specification: <ul style="list-style-type: none">• Active• Disabled
<i>Insurance Value Calc Query Name</i>	Select a query from the dropdown list of User Queries that indicates how the value for insurance should be calculated for an order. This query will run and populate the Insurance Amount field for the shipping request.

Additional Charges 1 through 10

Select one or more Additional Charges to be calculated with this shipping specification. If no Additional Charges are specified, the carrier’s actual freight charge will be used.

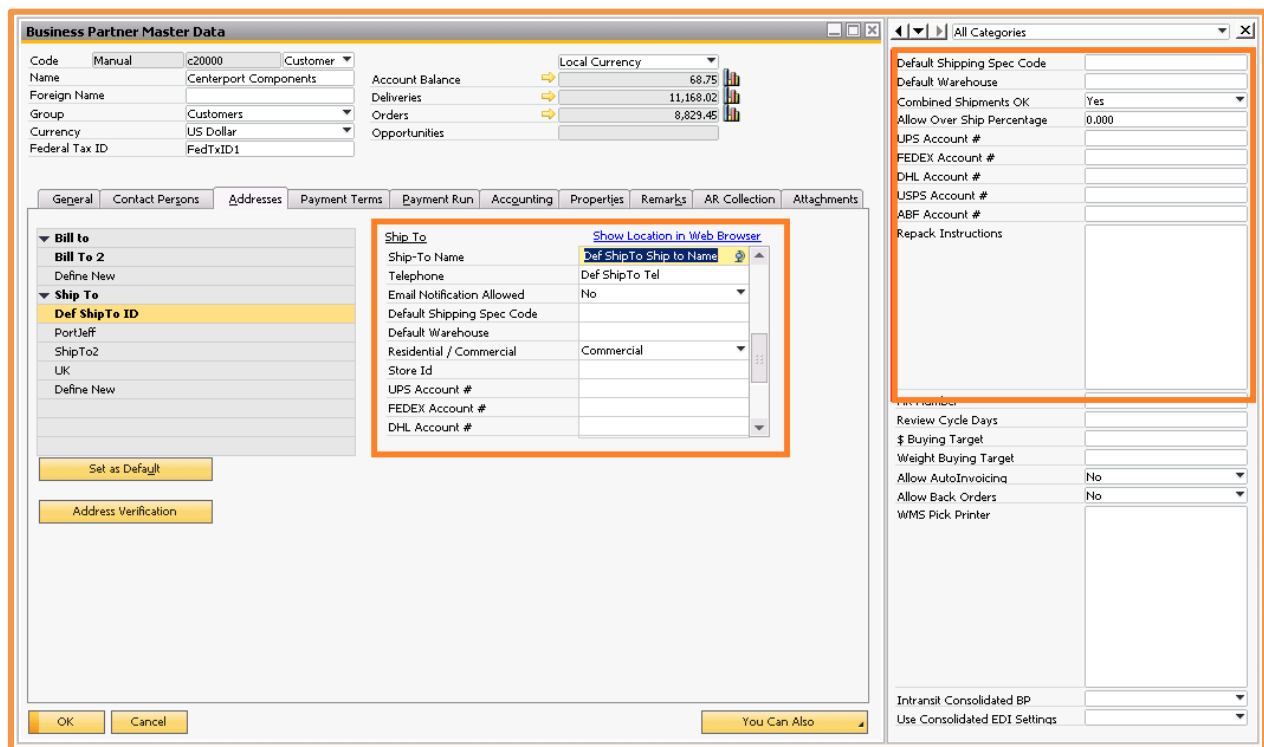
Freight Bill-To Information

In the case that the Freight Charge Type is set to “Third Party” these fields will be available. Enter all information regarding the third party individual or company that will be billed for the freight charges.

Business Partner Master Setups

Business Partners > Business Partner Master Data

Achieve Freight Control adds a number of fields to the Business Partner Master. The fields may be seen on the User-Defined Fields panel, and also in the Addresses tab for Ship-To Addresses.

USPS Account #	Enter the customer’s US Postal Service account number. This will be used when billing USPS charges to the customer.
ABF Account #	Enter the customer’s ABF account number. This will be used when billing ABF charges to the customer.
Repack Instructions	Enter text in here if you would like it to pop up when repacking in the Shipping Request.

Ship-To Addresses

Enter the following information in the Ship-To addresses.

Note: *In cases where the same fields exist in both the Business Partner and Ship-To areas, the Ship-To fields will be checked first. If data is found there, it will be used. If the field is blank then the data from the Business Partner will be used.*

<i>Ship-To Name</i>	This will be entered into the Ship-To Address Name field when a Shipping Request is created.		
<i>Telephone</i>	If there is no default telephone number on the BP then this will be entered into the Contact Phone field when a Shipping Request is created.		
<i>Email Notification Allowed</i>	If marked No, then email notifications will not be allowed for this Ship To. If marked Yes then email notifications will be allowed for this Ship To. Note, an email may still not be sent depending on the settings on the Shipping Method and/or Shipping Spec.		
<i>Default Shipping Spec Code</i>	Enter the BP Shipping Specification for this Ship-To if applicable.		
<i>Default Warehouse</i>	Enter the default warehouse for this Ship-to.		
<i>Residential/Commercial</i>	Select "Residential" or "Commercial" for this address.		
<i>Store ID</i>	Can be used to identify locations when using Third Party Integrations such as Webstores, etc.		
<i>UPS Account #</i>	Enter the address's UPS account number. This will be used when billing UPS charges to the ship-to.		
<i>FEDEX Account #</i>	Enter the address's FedEx account number. This will be used when billing FedEx charges to the ship-to.		
<i>DHL Account #</i>	Enter the address's DHL account number. This will be used when billing DHL charges to the ship-to.		
<i>USPS Account #</i>	Enter the address's US Postal Service account number. This will be used when billing USPS charges to the ship-to.		
<i>ABF Account #</i>	Enter the address's ABF account number. This will be used when billing ABF charges to the ship-to		
<i>Blind Ship Level</i>	Select the appropriate level for blind shipping. This setting controls what the recipient will see as the Ship-From address:

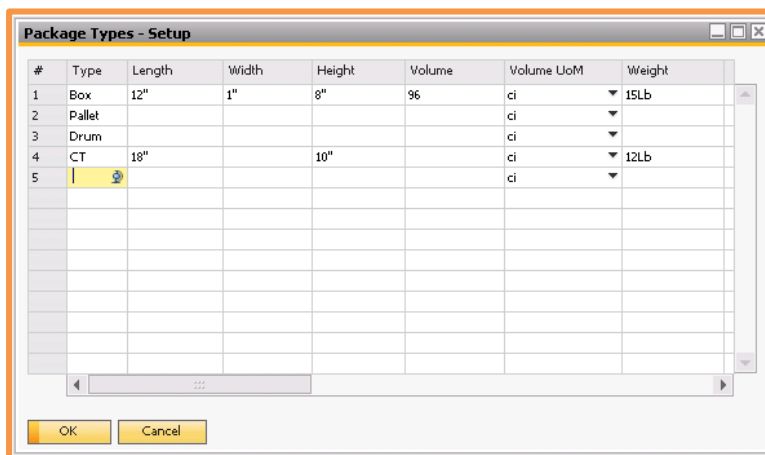

Item Master Setups

Inventory > Item Master Data

Achieve Freight Control adds several fields to the Item Master that have to do with packaging. The fields may be seen on the User-Defined Fields panel or on the Sales Data tab.

In addition to these fields, it is important to enter the item's dimensions and weight in the Sales Data tab. This information is used in Rate Shopping and other aspects of the Freight Control system. Note that if even one item on an order does not have weight, Rate Shopping cannot be completed for that order.

Note: Depending on your settings in the Freight Control configuration screen for “Std. Pack by UoM” you may use the standard SAP UoM and Package Type screen instead of the Achieve One fields for Standard packing. However, regardless of how that option is set you can still use the Achieve One fields for Master Packaging.

Procedures

The following sections describe the procedures used in Achieve Freight Control.

Summary of Procedures

The following is a summary of the Business One and Freight Control procedures. Each element is discussed in detail in the remaining sections of this manual.

Note: *Procedures would be somewhat different if you are using **Achieve Warehouse Management** in conjunction with **Achieve Freight Control**.*

- Enter a Sales Order
- (Optional) Use Rate Shopping to estimate freight charges
- (Optional) Copy the Sales Order to a Reserve Invoice if payment is required in advance
- (Optional) Use Pick & Pack Manager to create and print pick ticket
- Create the Shipping Request
- Create from button on Sales Order, Reserve Invoice, or Pick Ticket screen

OR

- Create from Shipping Request screen by copying from Sales Order, Reserve Invoice, or Pick Ticket
- (Optional) Print pick ticket from Shipping Request. This may occur automatically based on system settings.
- Pick and pack the order
- Enter package information in Shipping Request
- Scan items as packed

OR

- Use options on Shipping Request Packages tab
- Use the carrier’s system to weigh and label the packages, and create the manifest
- (Optional) Print packing list from Shipping Request. This may occur automatically based on system settings.
- From the Shipping Request, create the Delivery and/or Invoice
- Mark the Shipping Request complete

Options on Business One Documents

Business One Sales Orders, Reserve Invoices, and Pick Tickets have additional options when using **Achieve Freight Control**.

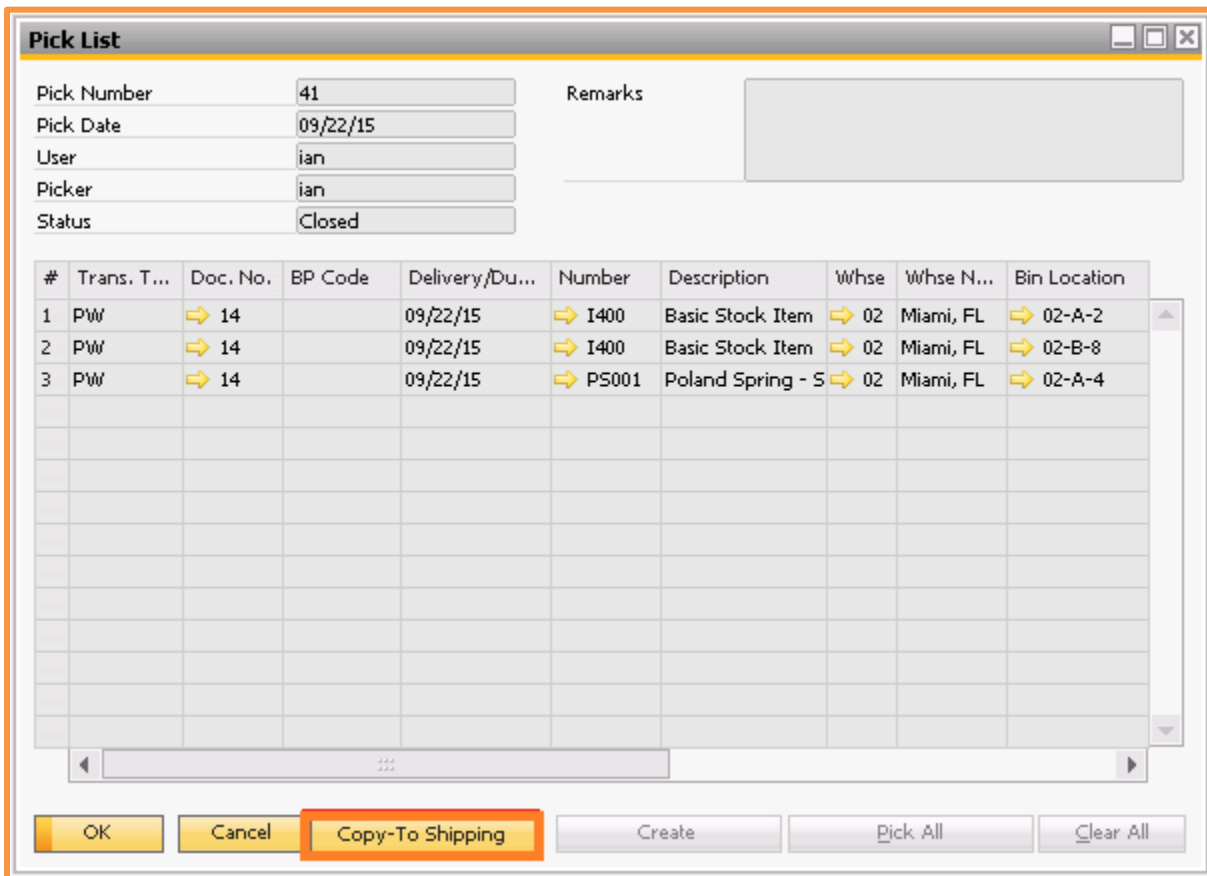

Note: If multiple orders are included on the Pick List, the system will create multiple Shipping Requests. Orders may be combined if they have the same customer, warehouse, delivery date, shipping method, shipping spec and ship-to.

Ship-To Addresses

As always, it is very important to include the correct Ship-To address on Sales Order documents. Standard SAP procedures allow you to set the Ship-To on the Logistics tab in several ways:

- The customer's default Ship-To automatically appears on the document
- Select an alternate Ship-To from the drop-down list
- Use the 3-dot button to enter a new Ship-To address

While in the Address Details screen you will see a button labeled Address Verification. You can click this button to have the system connect to the carriers behind the scenes and verify the address. If it finds a better alternate address it will suggest it. Note, this requires Rate Shop credentials to be entered in the Carrier Set-up like we saw earlier.

Achieve Freight Control provides several enhancements to this procedure.

First, based on the options in the Freight Control Configuration, you may choose to automatically save a new Ship-To address as a permanent record in the Business Partner or you may choose to save it only temporarily on this Sales Order.

The User-Defined Fields panel shows that there are many UDF's that have been added to the Sales Order for use by the Freight Control system. The fields relating to the "Temporary" address are used to store whatever address is to be used for shipping purposes. The system will automatically copy the selected or edited address selections from the Logistics tab into these fields.

Note: The "Temporary Ship-to Attention" field may be used to provide the Attention-To name that is transmitted to the shipping carrier system. You may use this field even if there is no change in the Ship-To address on the order.

Additional Fields on Sales Orders

UDF Panel

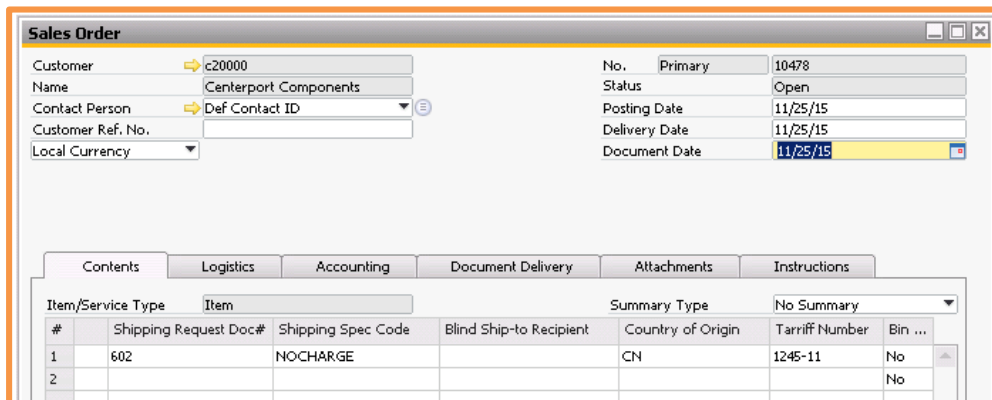
A number of fields in the UDF panel will display data that is derived from the Ship-To address on the BP Master; for example the Shipping Spec Code, Warehouse, and Blind-ship information. If desired, you may edit these fields to override the default information if a variation is required for this particular order.

Similarly, the Third-Party information is derived from the BP Shipping Specification, but may be added, removed or changed as needed for the particular order.

Logistics Tab

The Logistics tab includes a field for the BP Specification. This will default from the BP Master or the Ship-To record if available. It may be changed for this order if necessary.

Sales Order rows contain fields for the Blind Ship-To Recipient and the Shipping Spec Code. Depending on the settings in the Company Defaults these fields may be used to provide alternative information relative to the specific line items on the order instead of the document-wide settings on the Logistics tab and UDF panel.

After a Shipping Request has been created, the SR Document Number will be displayed on the Sales Order row.

Rate Shopping

The Rate Shopping feature allows you to view possible freight charges for various shipping methods. You can see all methods for a carrier and compare the rates for a specific shipment. This feature is particularly useful for companies where orders are placed while a customer is on the telephone with the operator, so that you can quote and compare estimated freight charges for the order and allow the customer to select the shipping method.

Note: Rate Shopping is a service offered by the carrier and you must subscribe to their service. The Rate Shop license, user ID, and other information must be entered in the Carrier Setup as we saw above.

Once an order is entered, you may click on the Rate Shop button. The system determines the carrier for the shipping type entered on the order. If Rate Shopping is enabled for that carrier a list of the available shipping methods for that carrier is displayed. The charge for each method is shown for the items on the order as it would be delivered to the ship-to address. If Rate Shopping is also available for an alternate carrier you may select it by means of the carrier buttons at the bottom of the screen.

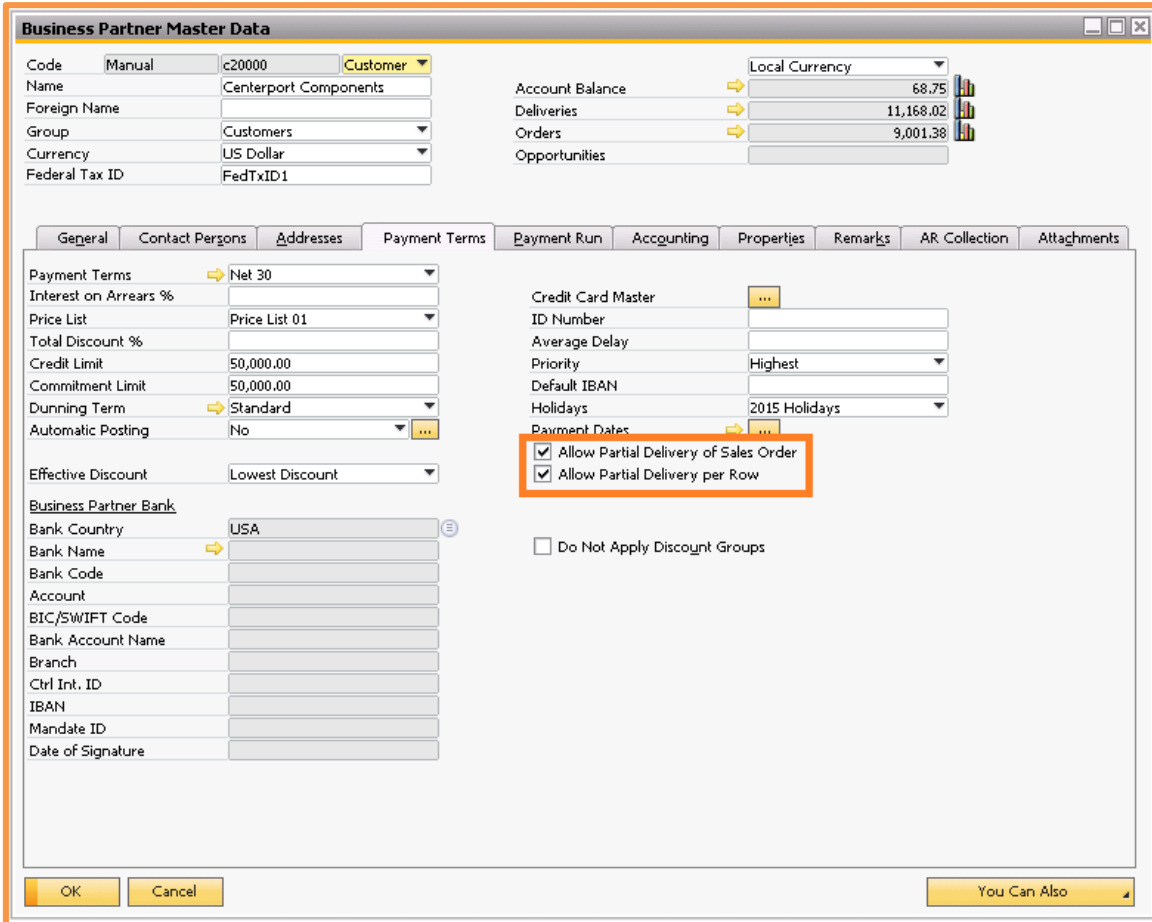

Each row of the Sales Order contains a checkbox to indicate if partial delivery is allowed for the row (e.g., only ship the available quantity of the item if the full amount is not in stock). The field defaults from the customer master but may be changed by the user.

Achieve Freight Control follows the requirements of the system regarding partial deliveries. Regardless of the method of creating the Shipping Request, the system will not do so for an order if the Logistics tab is not marked “Allow Partial Delivery” and all line items and quantities are not selected and if the full quantity of all items is not available in the warehouse.

Similarly, the system will not permit an item to be included on a Shipping Request if the row does not have the Partial Delivery box checked and all quantities are not selected and if there is not sufficient quantity of the item to ship the full amount.

If any of these situations occur, you will receive a message indicating that the order or row is not allowed for partial delivery and that the Shipping Request cannot be created. In the case of a row that must be shipped complete you can choose to create the Shipping Request without that row if necessary.

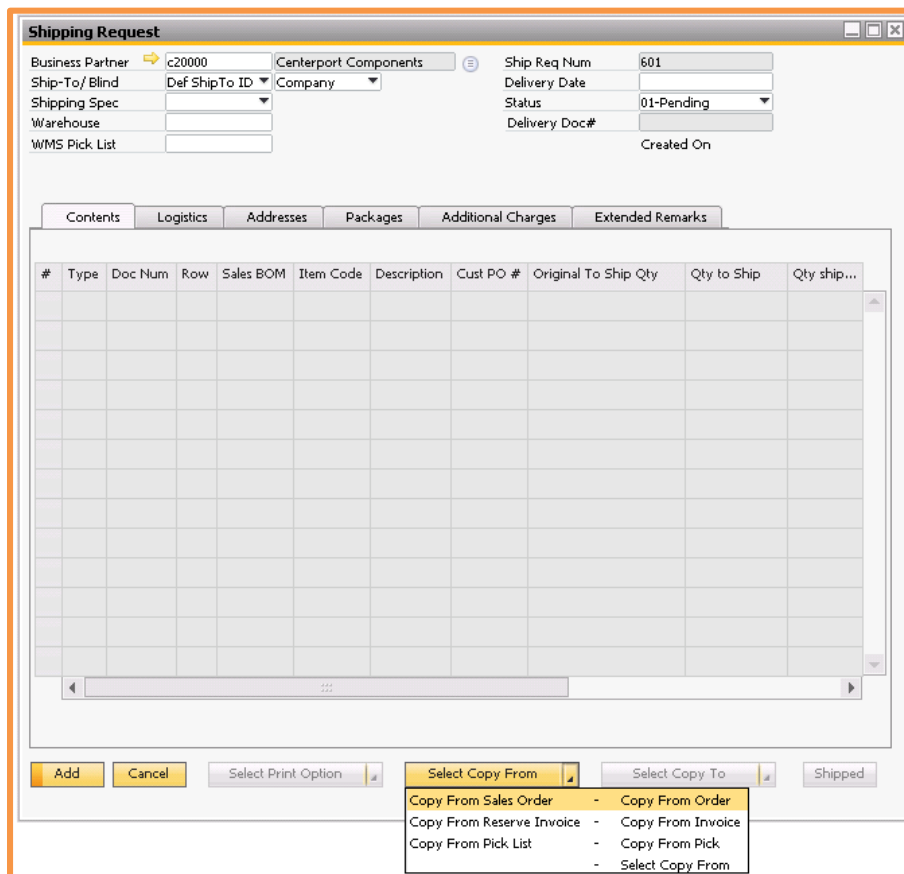
Shipping Request

The Shipping Request screen is the main focus of the Freight Control system. It contains all information about each shipment. It may be created from Sales Orders, Reserve Invoices, or Business One Pick Tickets, and it can be used to create Deliveries or A/R Invoices. It may also be used to communicate with a carrier's shipping system for complete control and information about each shipment.

Entering a Shipping Request

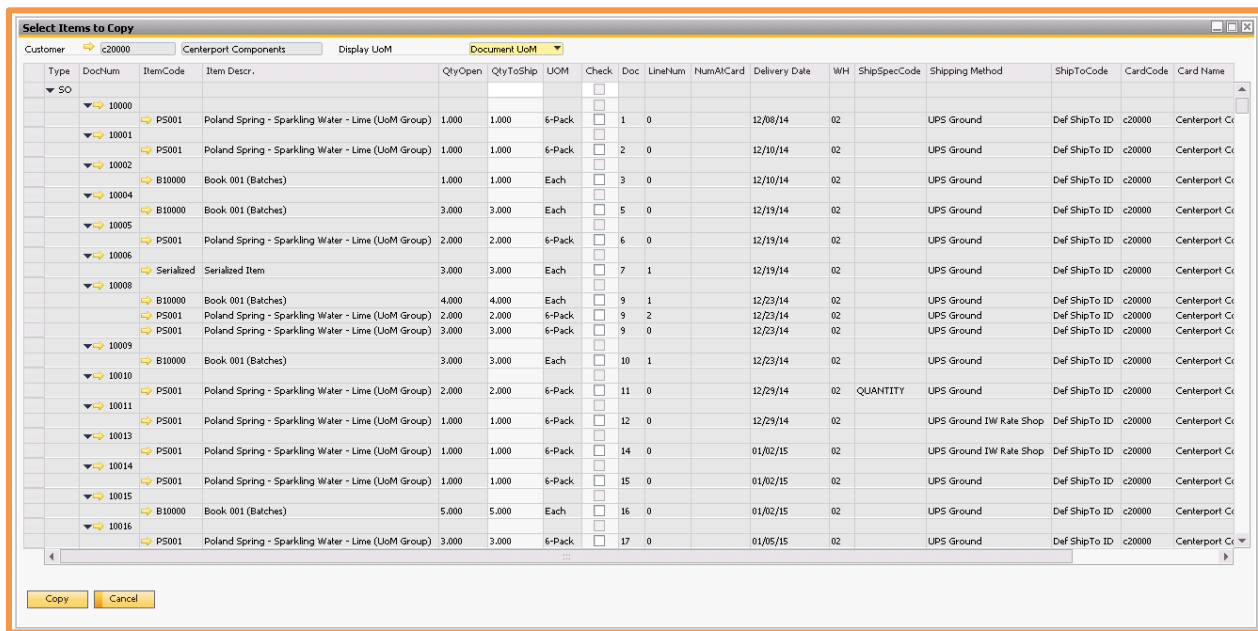
You may create a Shipping Request by using the “Ship” or “Copy to Shipping” button on the Sales Order, A/R Reserve Invoice, or Pick Ticket screen. Alternatively you may open the Shipping Request document screen directly to create a Shipping Request.

Start by entering a customer code in the Business Partner field. You then are able to copy from either a Sales Order, Reserve Invoice, or an SAP Business One Pick List. Click on the “Select Copy From” button, and choose the appropriate document type to display the available documents to copy.

The list includes detail of the items on each document including the ordered quantity and shipping method. There is also an option at the top to see the quantities in either the Document UoM or the Inventory UoM.

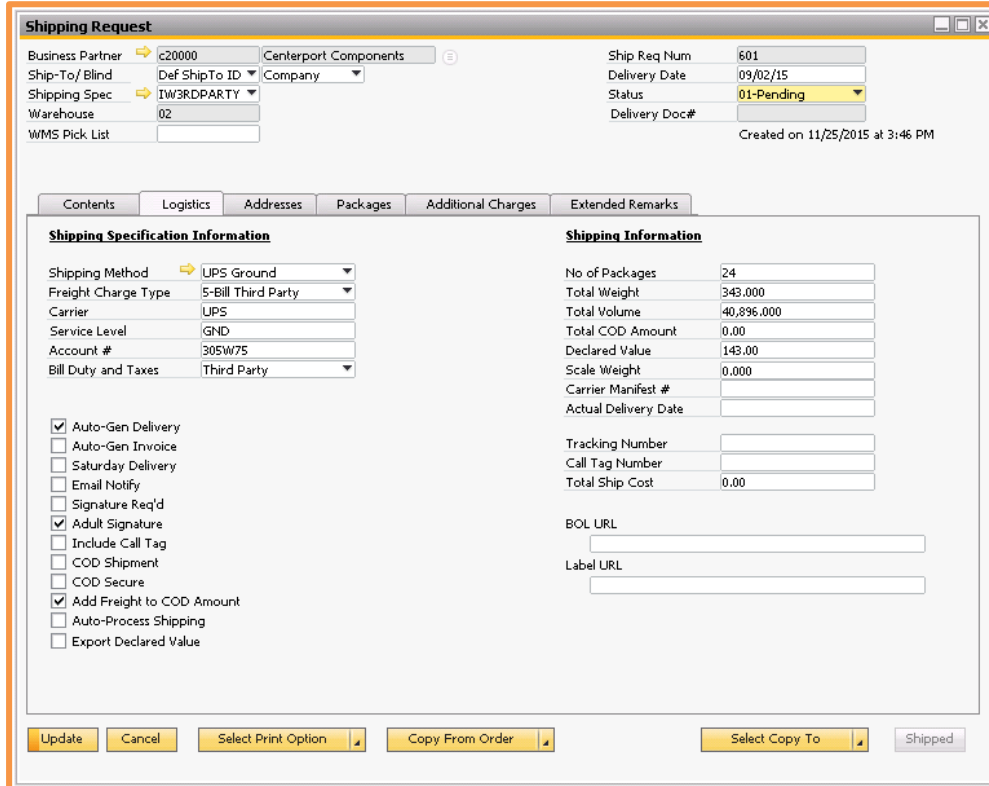

Ship-To Information – this is the ship-to address from the sales order. You can also click on the Address Verification button like we saw earlier, to verify the address.

Ship-From Information – this is the information that the recipient will see indicating who the shipper is. It is determined as follows:

- If the “blind ship level” on the ship-to record is “Null”, the Ship-From information will be the Shipping Request Warehouse’s name, address, contact, and telephone number taken from the Warehouse setup and Company Details in SAP.
- If the “blind ship level” on the ship-to record is “Blind”, the Ship-From information will be the customer’s name, bill-to address, default contact, and telephone number taken from the customer on the sales order.
- If the “blind ship level” on the ship-to record is “Double-Blind”, the Ship-From information will be the name and address of the ship-to address listed as the “Blind Parent” on the ship-to record.

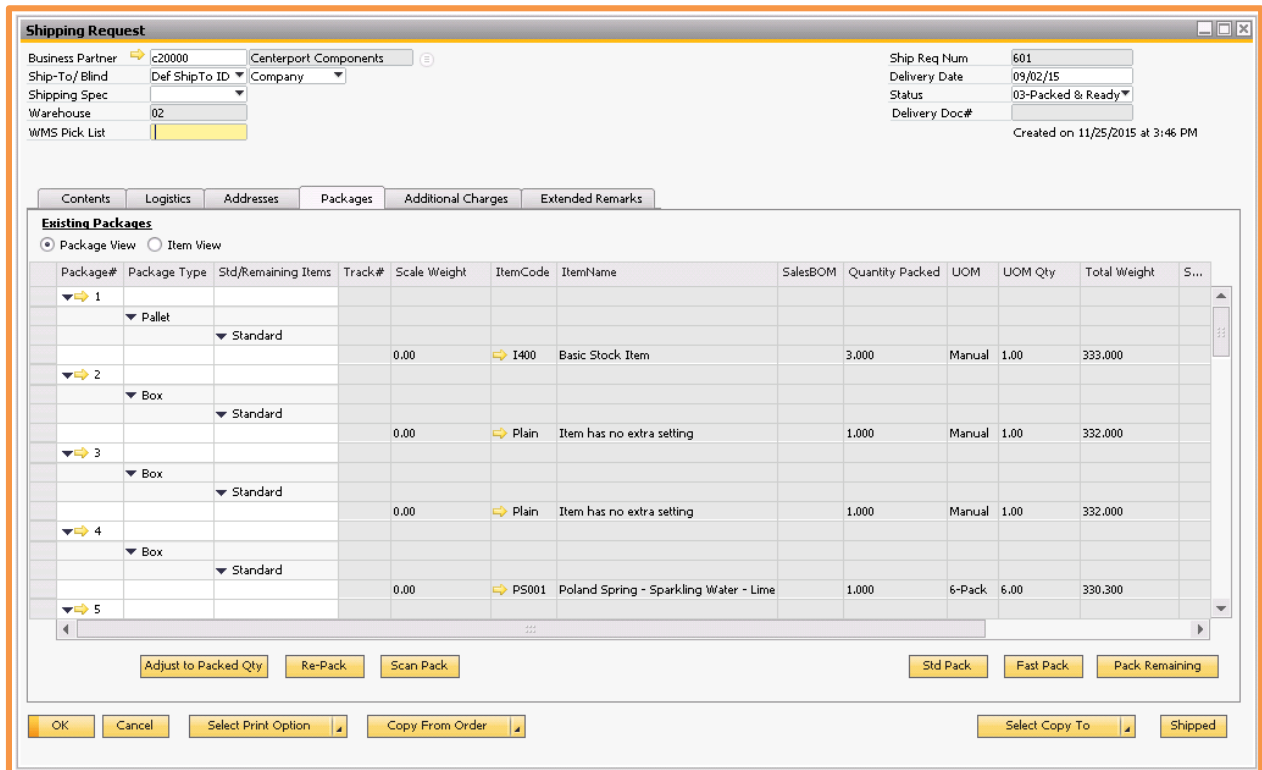
Bill-To Information – this is the name and address of the company that will be billed by the carrier for the freight charges on the shipment. It is determined by the setting on the Shipping Method or Shipping Specification.

- Bill Company – The name and address of your company will be shown.
- Bill Customer – The name and address of the customer will be shown.
- Bill Ship-To – The name and address of the ship-to will be shown.
- Bill Consignee – The name and address of the consignee must be entered manually by the user.
- Bill Third Party – The name and address of the third-party entity who will pay for shipping is taken from the Shipping Specification.

Packages Tab

The Packages tab of the Shipping Request is used to review and manage the packages used in the shipment. You may view previously packed items either by package or by item.

This tab is also used to manage the packing process. Several options exist to create packages including Standard Packing, Fast Packing and Scan Packing.

If packaging is not required, the shipment is automatically “Fast Packed” when it is added, with all items “packed” in a single package (package 0). If this is not the desired packaging for your Shipping Request or if for any reason you need to pack the shipment again, you can click on “Re-Pack”.

If packaging is required, the system does not automatically assign any packages. You may use one of the packaging options on this tab to assign items to packages.

The following process is used with the *Fast Pack* option:

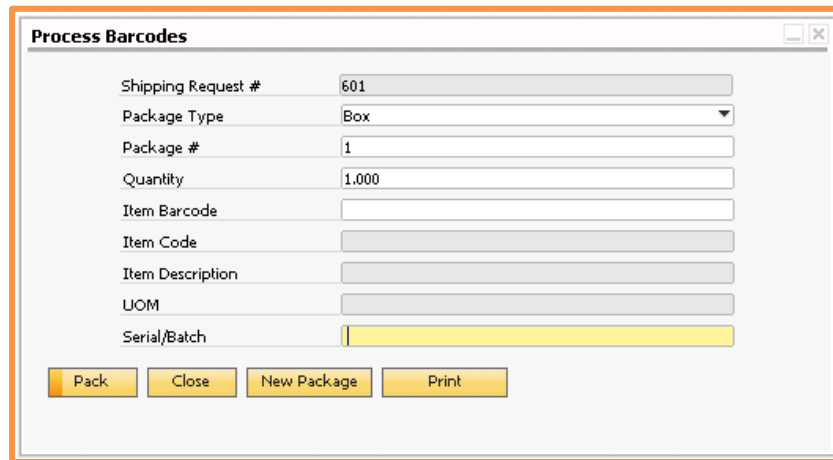
- The system checks each item to determine whether it is set to use standard packs and what the pack quantity and package code are. Packages will be assigned accordingly.
- Each package will contain the maximum quantity of the item specified in the item master up to the quantity of the item in the shipment. Remaining quantities will be considered “items remaining”. For example, if the package quantity for an item is four but the shipped quantity is 10, the system will create two packages of four each with two items remaining.
- Items that do not use standard packaging, cannot be standard packed or do not have the pack size and codes entered, will be included in the “items remaining” group.
- When the system is done packing all “items remaining” will be packed into a single left-over package.

The following process is used with the *Standard Pack* option:

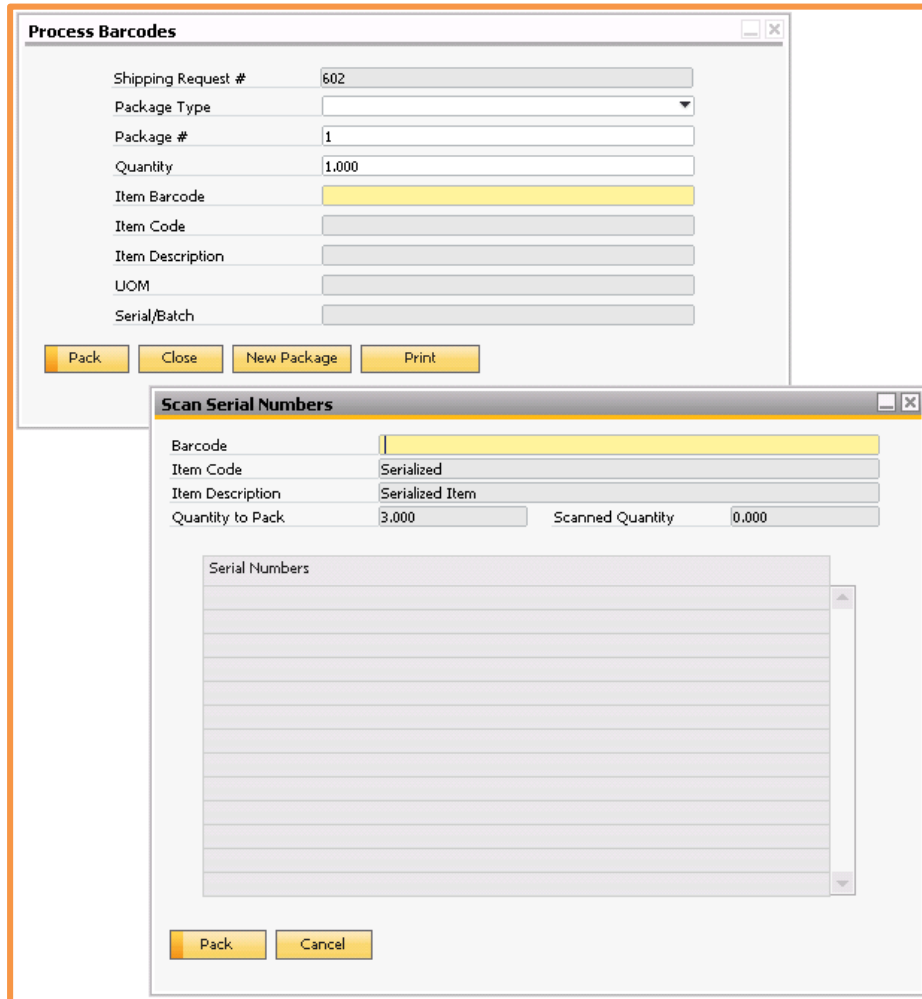
- The system checks each item to determine whether it is set to use standard packs and what the pack quantity and package code are. Packages will be assigned accordingly.
- Each package will contain the maximum quantity of the item specified in the item master up to the quantity of the item in the shipment. Remaining quantities will be considered “items remaining”. For example, if the package quantity for an item is four but the shipped quantity is 10, the system will create two packages of four each with two items remaining.
- Items that do not use standard packaging, cannot be standard packed or do not have the pack size and codes entered, will be included in the “items remaining” group.
- When the system is done packing, all “items remaining” will be left unpacked for the user to manually complete packaging.

The following procedure is used in the *Scan Pack* process:

- The “Process Barcodes” screen is displayed. Although entries may be made by means of the keyboard, it is more common to use a scanner to enter the data for each field.



- Select the Package type for the first package.
- Enter the quantity of the first item and then the barcode and click on “Pack”.
 - For batch items, enter in the quantity of the first batch that you want to pack into this package then enter the batch number in the last field. If there is more than one batch of the same item, enter the quantity of the second batch and its batch number; continue until all of the batches have been entered for this packages.
 - For serial items, if the total quantity of the item is one, then enter that serial number in the last field. If the total quantity of the item is greater than one then you have two options. The first is to enter each serial number with a quantity of 1. The second is to enter the total quantity and click on “Pack”. That will open a new window to scan multiple serial numbers at once. Enter all of the serial numbers for the item then return to the “Process Barcodes” screen.

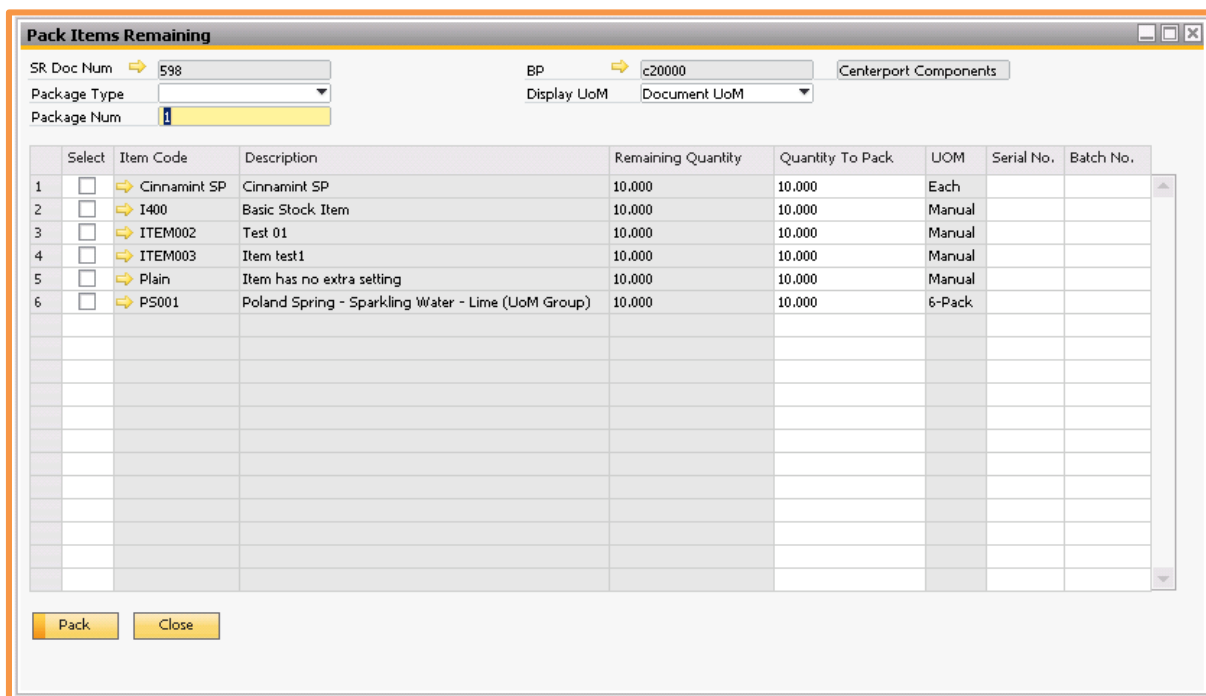

- Continue entering items until the first package is completed. Then click on “New Package” and enter the information for the next package.
- Continue until all items in the shipment have been packed.

The following procedure is used in the *Pack Remaining* process:

- Enter in the package type and number.
- Choose with UoM to display the quantities in, Document or Inventory.
- Check the boxes of the items to pack in this current package.
- Enter the quantity to pack for each item selected.

- If the item is serialized or batched enter in the serial/batch numbers to pack.
- When all items for this package have been packed click on the Pack button.
- If there are items still remaining to pack it will increment the package number and allow you to continue packing.
- If there are no items remaining to pack it will give you a message saying so and close the pack remaining screen.

There are also other buttons at the bottom of the Packages tab that perform the following functions:

Adjust to Packed Qty

The system will adjust the qty to ship of the items on the Contents tab to match the total of the packed quantity of each item.

Re-Pack

Deletes all previously entered packaging information for the shipping request.

Scan Pack	Opens the Package Barcodes form to allow the creation of packages by scanning items as they are packed as described above.
Std Pack	Performs the packaging functions described above.
Fast Pack	Performs the packaging functions described above.
Pack Remaining	Opens the Pack Remaining screen to allow for manual packing of all items that have not been packed yet as described above.

There are two different views for the packages tab; **Package View** and **Item View**. The following information is included in the **Package View**:

Master Package	If Master Packages are enabled, the master package number is shown. This is a sequential number and is not related to any actual number on the shipment.
Master Package Type	The code for the Master Package type is shown.
Package #	The package number is shown. This is a sequential number and is not related to any actual number on the shipment.
Package Type	The code for the package type is shown.
Std/Remaining Items	This field indicates whether this package was packed using standard packaging or consists of remaining items.
Track #	The package tracking number is entered by the carrier system after processing.
Item Code	The item code is shown.
Item Name	The item description is shown.
Sales BOM	In the case of a Sales BOM item the parent item code is shown.
Quantity Packed	The quantity of the item in the package is shown.
UOM	The unit of measure for the packed item is shown.
UOM Qty	The quantity to convert the displayed UoM to the Inventory UoM is shown.
Total Weight	The total weight for the package including the tare weight is shown.
Serial #/Batch #	The serial or batch number(s) for the items in the package are shown if applicable.
Carrier ID	This is a field that you may manually enter data in by drilling into the Package Master Data. If using Achieve Warehouse Management this field may be entered on the Handheld while packing.
Seal	This is a field that you may manually enter data in by drilling into the Package Master Data. If using Achieve Warehouse

Inspection Seal

Management this field may be entered on the Handheld while packing.

This is a field that you may manually enter data in by drilling into the Package Master Data. If using **Achieve Warehouse Management** this field may be entered on the Handheld while packing.

The Item View shows the same information arranged by item with the addition of two extra fields:

Qty Remaining to Ship

The total quantity of the item that is remaining to ship (pack) is shown.

Qty Shipped

The total quantity of the item that has been shipped (packed) is shown.

Note: All fields may be edited and lines may be added or deleted by means of right-click options. If any changes are made, click on “Calculate Charges” to recalculate the charges.

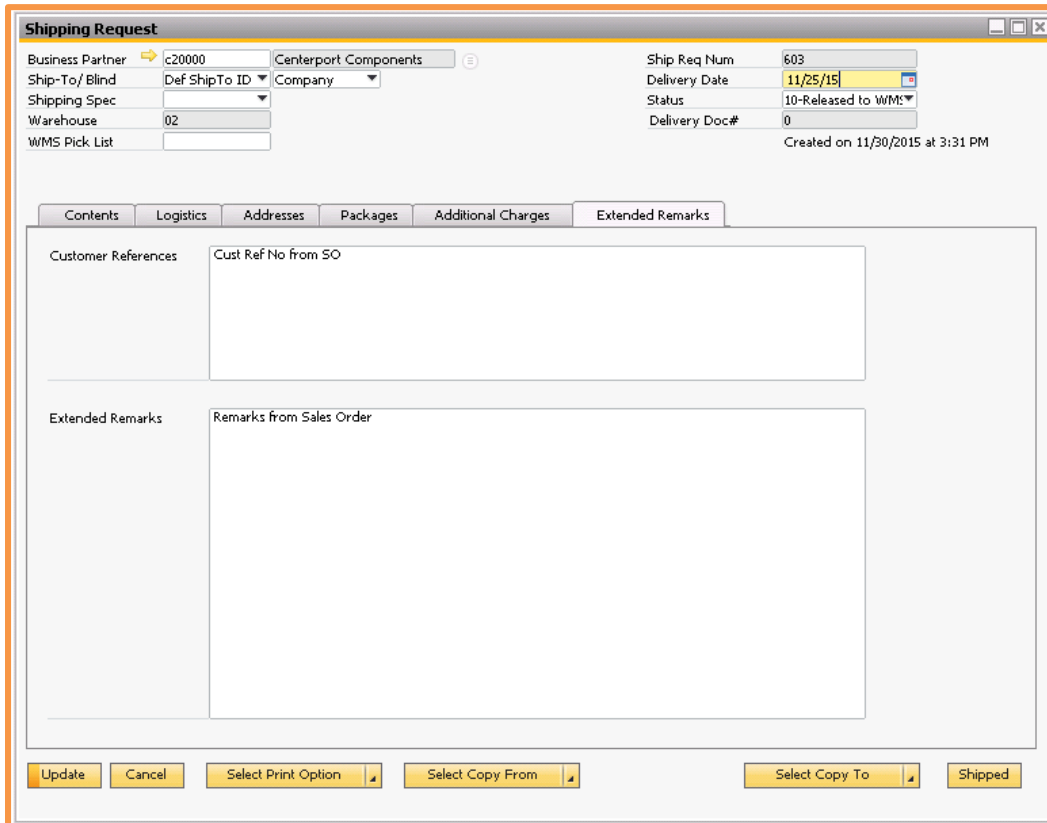
Note: If a particular Additional Charge is based on a value that has not yet been determined (such as shipping cost prior to getting that amount from the carrier), the calculated amount will be set to zero.

When the items have been shipped and the Delivery and/or Invoice has been created, the total of the Additional Charges will be copied to the documents as the freight charge. If there are no Additional Charges, then the actual shipping charge from the carrier will be used.

Note: In cases where the Freight Charge Type is Bill Customer, Bill Ship-To, Bill Consignee, or Bill Third Party, no freight charges will be copied to the Delivery and/or Invoice because the carrier will bill the freight charges directly with those options. The only exception is when the Additional Charges shown are set to “Always Charge on Delivery”. In those cases freight will still be copied to the Delivery and/or Invoice.

Extended Remarks Tab

The Extended Remarks tab will bring information in from the base document, and will also allow you to enter whatever instructions or details that may be needed for the shipment.

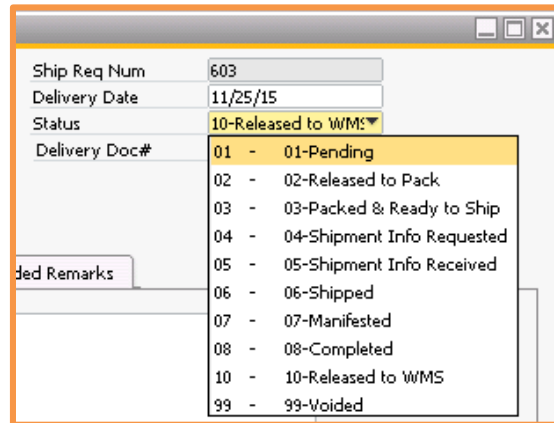

You may edit or add to these fields if desired with information such as shipping instructions or details desired for the processing of the shipment.

Status Codes

There are 10 possible status codes for the Shipping Request document. In some instances, the code is changed automatically by the program. In others, it is necessary to change it manually or by means of the Shipping Management program.

Note: *It is not necessary to use all status codes with every shipment.*



Pending

This is the default status for new Shipping Requests. It indicates that no action has been taken yet.

Released to Pack

The Shipping Request is ready for packing. If the pick ticket has not yet been printed it may be printed at this point.

Packed & Ready to Ship

The packages are ready to ship. This code will be set automatically when scanning or other packaging is complete. If the packing slip has not yet been printed it may be printed at this point.

Shipment Info Requested

Information is needed from the carrier's system.

Shipment Info Received

Information has been received from the carrier's system. This code will be set automatically when shipping costs, scale weights and tracking numbers are received from the carrier system.

Shipped

The shipment has been sent out of the warehouse. The Delivery document and/or Invoice may be created at this point. You may set this status by clicking on the "Shipped" button at the bottom right of the shipping request screen.

Manifested

If manifesting is enabled this status indicates that the shipment has been included in a manifest to the carrier company.

Completed	The shipping request is complete. No further action is needed. No changes are allowed once the shipment is marked Completed.
Released to WMS	When using Achieve Warehouse Management and picking by Shipping Request this is the status of the Shipping Request when the Logistics Manager creates it. It will stay in this status until it is picked on the Handheld.
Voided	The shipping request is cancelled. No changes are allowed once the shipment is marked Voided. If using Achieve Warehouse Management and the Shipping Request was already picked, the items will be moved to a designated return bin.

Printing

Four forms may be printed from the Shipping Request screen; Pick List, Pack List, Packaging Label and Pre-Packaging Label.

The Freight Control Configuration provides the option to automatically print any of these forms. If any of the options are set to auto print then the forms will print automatically throughout the Shipping Request process. If auto printing is not selected or if you wish to reprint a document at a later time, you may use the “Select Print Option” button at the bottom of the screen to print any of the defined forms on demand.

If **Achieve Document Delivery** is also installed, you may use the right-click option to Deliver any Crystal Reports form to any recipient by means of printing, email or fax.

Serial and Batch Numbers

Items that are managed by serial or batch numbers must have the serial or batch selection entered as part of the packing process. Deliveries for these items cannot be completed without a complete selection of serials or batches.

The Fast Pack and Standard Pack methods do not let the users enter in serial or batch numbers so they cannot be used for these types of items. To pack these items it is necessary to use the Pack Remaining or Scan Pack features since they allow the entry of serial and batch numbers. See detailed instructions in the section above regarding the Shipping Request document Packaging tab.

Note: *If you are systematically picking the orders by way of the SAP Pick/Pack Manager or **Achieve Warehouse Management** then you may be able to fast pack or standard pack serial and batch items. This is because during the picking you are already selecting the serial and batch numbers to be packed. There are however only a few scenarios where this can work however:*

Serialized Items

- Can be Fast Packed into a single package using the Fast Pack button.
- Can be auto packed into Package 0 when packaging is not required as per Freight Control Configuration.
- Can be auto packed when Freight Control is configured to have Pick List Packaging set as "Package in Single Package".
- Can be auto packed when using **Achieve Warehouse Management** and WMS is configured to Package in Single Package.

Those are the only scenarios for serialized items.

Batched Items

- Can be Fast Packed into a single package using the Fast Pack button.
- Can be auto packed into Package 0 when packaging is not required as per Freight Control Configuration.
- Can be auto packed when Freight Control is configured to have Pick List Packaging set as "Package in Single Package".
- Can be auto packed when using **Achieve Warehouse Management** and WMS is configured to Package in Single Package.
- Can be Standard Packed as long as all of the batches for a specific item are the same, meaning that it will not matter which batch you put into which package since there is only one batch for that item.

Those are the only scenarios for batches items.

Creating Deliveries and Invoices

Delivery and A/R Invoice documents may be created in several different ways, depending on the options selected in the system. Regardless of the method of creation, the Delivery document number will be shown in the Shipping Request header.

Automatic Creation

The Freight Control Configuration screen contains options as to whether to allow automatic creation of Deliveries and Invoices.

If automatic creation (“Auto Gen”) is allowed it may or may not be set as the default on a shipping method or shipping spec.

The default setting may be changed on the Logistics tab of the Shipping Request if necessary.

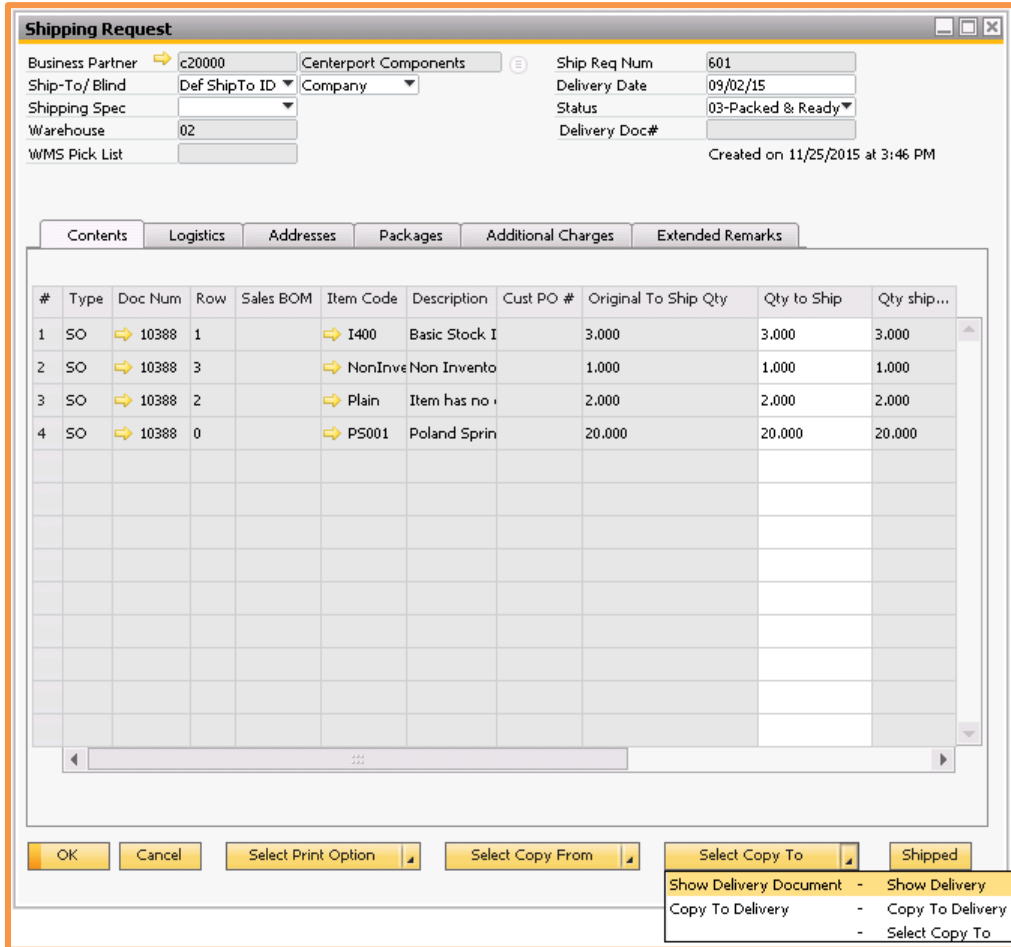
The Delivery document will be created by the system when the Shipping Request status code is changed to “Shipped” or “Manifested”.

The A/R Invoice will be created by the system immediately after the Delivery is created.

If Deliveries are not used, the A/R Invoice document will be created by the system when the Shipping Request status code is changed to “Shipped” or “Manifested”.

Manual Creation

If automatic creation is not used, then you must create Delivery and/or Invoice documents manually.

You may create the Delivery by clicking on the “Select Copy To” button and then choosing either “Copy to Delivery” or “Show Delivery”.

Note that the status code must be “Shipment Info Received” or subsequent.

“Copy to Delivery” will create the Delivery document directly from the Shipping Request without any further input from the user.

“Show Delivery” will open the standard SAP Delivery document screen. It will first populate the customer code then select the “Copy From” option automatically and select the appropriate Sales Orders or Reserve Invoices document. The system will then populate the

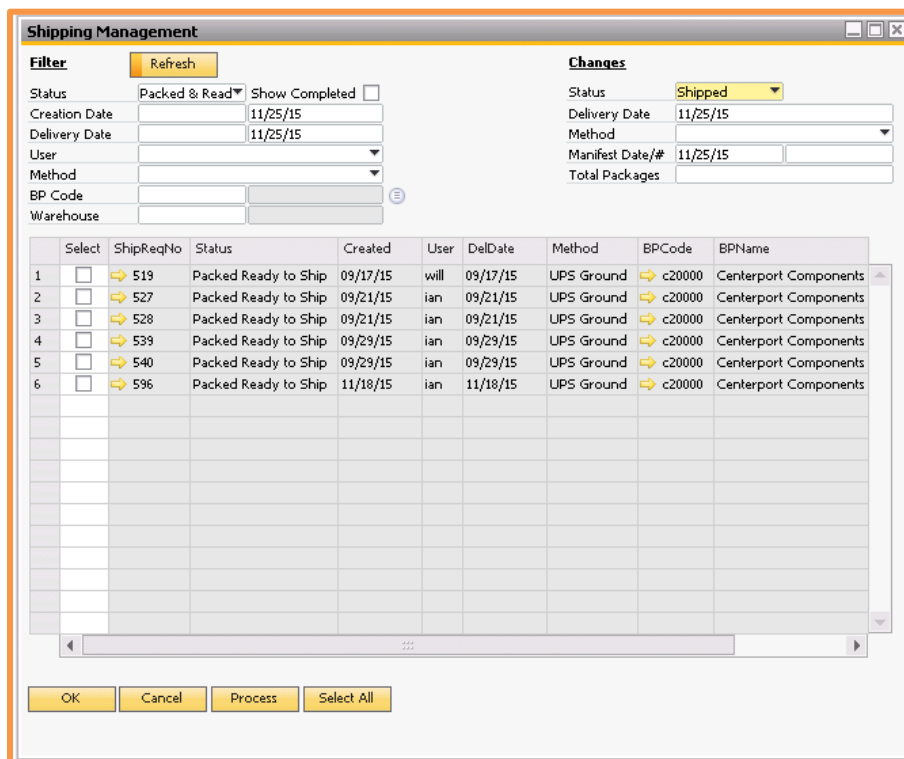
rows from the Shipping Request. The user must click on “Add” to complete the entry. This allows the user to make changes to the Delivery before it is added if necessary.

The user may need to select the bin locations and batch/serial numbers depending on your warehouse and item settings.

If automatic invoice creation is not selected the A/R Invoice must be created with the standard SAP process of using “Copy From”, “Copy To”, or the Document Generation Wizard.

Shipping Management

The Shipping Management program is used to change the status (as well as some other fields) on groups of Shipping Requests at the same time. This is a very useful feature since it allows users to proceed from one function to the next without having to change each document individually.

On the left side of the header enter the criteria for which Shipping Requests to display. In the example above we are trying to see all Packed & Ready to Ship shipping requests with a creation and delivery date through 11/25/2015. Other criteria options might be to select all

shipping requests that are pending with a particular shipping method or all documents from a particular customer.

Note: The “Show Completed” checkbox will also show Completed shipping requests that match the criteria in addition to the shipping requests that match the status selected from the drop down.

On the right side of the header, enter the new values that are desired for the selected Shipping Requests. Most commonly this would be a new status code as in the example above. A manifest date might also be included as appropriate.

When the criteria and changes are complete, click on “Refresh”. The lower portion of the screen will then display all Shipping Requests that meet the selection criteria. Check the “Select” box to confirm each one that should be changed or use the “Select All” button if you want to change all of the ones displayed.

When you have checked all the selection boxes of the shipping requests you want to change click on “Process”. The selected shipping requests will then be changed in accordance with the specifications on the screen. Note that if documents are changed to status “Shipped” or “Manifested” and Freight Control is set to automatically create deliveries, a delivery for each Shipping Request will be created as part of this procedure.

Fast Scan and Pack

The Fast Scan and Pack screen is used to record the scanning that takes place in the warehouse after items are picked and brought to the shipping area. Although it is possible to make entries with the keyboard, it is assumed that most of the time a wedge scanner will be used.

To begin, enter the command for the function to be performed. You can create barcode labels to scan for each of the commands. The commands are shown to the right of the header fields. If using the keyboard, you must type the slash marks (//) before the command. Press TAB after typing the command word.

You can then enter boxes, items, serial/batch numbers, and quantities as needed. Note that in the case of serialized items, you may scan the serial number alone and the system will determine the item code. It assumes a quantity of one for each serial number.
